Sectional wrestling meets involve 11 area schools

All 11 area high school wrestling teams will be taking part in sectional meets this Friday and Saturday in Ohio's first step to determine 13 weight class champions in the various divisions. The teams will be wrestling at four different sites.

Ross, Bellevue, and Port Clinton will travel to Bellevue High School to take part in that 12-team "AAA" event while the remainder of the Genoa, and Gibsonburg will

schools will be in action at Maumee High School, Huron High School, and Heidelberg College in the "A-AA" meet. The two smaller classes are combined in state competition.

Fremont St. Joe, Clyde, and Lakota will travel to Heidelberg College while Margaretta is the lone area team in the Huron sectional. Oak Harbor, Woodmore, Genoa, and Gibsonburg will

be at Maumee in the two-day wrestling meet.

Sandusky is the pre-tourney favorite according to the seeding handed out at the coaches meeting. The Blue Streaks have seven seeds while Mansfield Madison and Findlay are close behind with six each. Ross has a total of four seeded wrestlers with one in the top seeded spot.

Larry Parks, Ross 167-pounder with a 16-1 record is the favorite to cop the sectional title at that weight. Other seeded Ross wrestlers are Steve Reiter, third at 155; Tony Munoz, third at 98; and John Kinkaid, fourth at 175.

Bellevue's unbeaten Frank DeLuca is the top seed at 155. DeLuca has a 17-0 mark. Bellevue also has Steve Schaeffer, third seeded at 138.

Port Clinton's only seeded wrestler is Tim Flynn (10-4-2) at 126 pounds. Flynn is seeded fourth.

St. Joe's Mike Widman is the lone top seed for the local team at Heidelberg. The Crimson Streaks are the defending champions of the sectional. Widman is a 167-pounder.

Other Streaks receiving seeds include Willie Zamora, fourth at 98; Bill Dirlam fourth at 119; Pete Norton, second at 126; Bruce Frederick, second at 138; Tom Hoelzle, third at 155; and Dale Courtney, second at 185.

Clyde is represented by Bob Imke, second at 112. Imke was fourth in the state at 98-pounds last year and is 13-0 this season. Other seeded Clyde wrestlers are Bill Cook, fourth at 138; and Dave Crockett, fourth at 185.

Jeff Carter is the top seeded grappler at 175. The Lakota Raider star has compiled a 16-2 mark this year. Other Raiders seeded are Gary Smith, third at 105; Steve Nieset, third at 145; Joe

Vetell, fourth at 167; Jeff Conley, third at 185; and Jeff Wyant, fourth in the heavyweights.

Jeff Winke and Chuck Biggert rated top seeds at the Maumee tournament. Winke is 17-0 at the 98 division while Biggert matches that figure at 145.

Rick Rickner is the number three seed at 119 for Oak Harbor while Jeff Kreager is third at 132. Dan Biggert is seeded third at 138 with Mark Mayer second seeded at 155. Jerry Goldstein is the 167-pound fourth seed to wrap up the Oak Harbor seeded wrestlers.

Genoa seeded wrestlers include Tom Skees, fourth at 119; Fred Huss, fourth at 145; and Terry Calhoun, fourth in the heavyweight class.

Gibsonburg's only seeded wrestler is Paul Tornow, third at 167. The Golden Bear wrestler is 12-6-1.

Steve Wegert drew the number two seeded spot at 138 with his 13-2 record. Wegert is the only seeded Woodmore wrestler.

At Huron's "A-AA" sectional meet, Margaretta's unbeaten (15-0) Jorge Santana is the top seed at 105-pounds. Santana is one of two Polar Bear seeded wrestlers.

Dave Dauch is the third seeded grappler at 119 pounds.

On Saturday afternoon, the semi-finals and the consolation quarter and semi-final matches will start at 1 p.m. The third session will be at 7 p.m. Saturday night and will include the championship and consolation (for third place) finals.

Tickets for all three sessions will be sold at the door. Tickets are \$1 for students and \$1.75 for adults. On Saturday, for students and adults wanting to attend both sessions of wrestling, students may purchase two tickets for \$1.50 while adults can get two for \$3. They must be bought at the same time for this discount.

Doors will open one-half hour before each session.

Five Ross wrestlers earn semi-finals in sectional

BELLEVUE — The Ross High wrestling team will send five men into the semi-finals of the 12-team Class AAA Sectional tournament today, and will be joined by four Bellevue wrestlers, as both teams are in the battle for the team championship, after quarter-final action Friday night.

The Little Giant wrestlers are currently in a third place tie with Mansfield Senior with $15\frac{1}{2}$ points and trail Findlay, who has $17\frac{1}{2}$, and host Bellevue, who has 17. Ashland and Mansfield Malabar are right behind Ross and Mansfield with $14\frac{1}{2}$, Sandusky has 14 and Galion, $13\frac{1}{2}$.

The Little Giants were paced by Mark Cooley in the heavyweight division who came up with two pins, pinning both Charles White of Mansfield Senior and Dave Stone of Galion.

Other Ross wrestlers in the semi-finals include Tony Munoz in the 101-pound division, Dan Skergan in the 129-pound division, Steve Reiter in the 158-pound division, and Larry Parks in the 170-pound division.

Parks has still lost only one match on the season as he decisioned Bellevue's Rick Hamer 8-2. Munoz also came up with two pins with match stoppers over Tom Mutsch of Ashland and Randy Koser of Mansfield Madison.

Pacesetter Findlay will send seven wrestlers into today's semi-finals and Mansfield, who is in a tie with Ross for third, will send six.

Port Clinton's lone wrestler into the semi-finals is Bruce Below who defeated Larry Hartley of Bellevue and John Kinkaid of Ross.

Today's semi-finals and finals begin at 1 p.m. with the consolation and championship finals at 7 p.m. tonight.



Parks wins sectional; Sandusky is winner

BELLEVUE — Sandusky edged Mansfield Senior 74½ to 71 for the Bellevue "AAA" Sectional Tournament title. The Blue Streaks claimed three individual championships while advancing six wrestlers to the district meet next weekend at Toledo Whitmer High School.

The top three wrestlers in each weight division advanced to next week's district wrestling.

Bellevue was fifth in the 12-team tournament while Ross was seventh and Port Clinton twelfth. Bellevue qualified four wrestlers to the district but lost one of those when 148-pounder John Schaffer suffered a hairline fracture of his leg in the last nine seconds of his semi-final match.

Ross claimed one weight division champion, 170-pound Larry Parks. The Ross senior breezed through the tournament and had few problems with Galion's Jon Logan in the championship match. Parks, using a "cradle" effectively throughout the match, rolled to an 11-1 decision for the sectional title.

The only other qualifier for Ross was Tony Munoz at 101 pounds. Munoz defeated Jerry Forney of Sandusky in the consolation finals, 7-3.

Ross 129-pounder, Dan Skerigan, was pinned in the consolation finals by Lloyd Tate of Mansfield Senior, in the only other match.

Northern, Wittenberg meet in OC title clash

CLEVELAND (AP) — Ohio has an 18-5 record and Northern and Wittenberg Wittenberg enters the contest meet here at Baldwin-Wallace College Tuesday night to decide the basketball championship in the Ohio Conference.

Ohio Northern won the conference's northern title Saturday night by downing Oberlin 65-54. Wittenberg put away Marietta 72-51 to win the southern title.

The teams played each other earlier this season and Ohio Northern came away with a 53-49 victory. Northern

involved a Ross wrestler a referee's decision. The match had ended 2-2 in the three, one-minute overtime periods but the three referees awarded the match to Moyer over Greg Jordon of Mansfield Madison.
