The area was shut out in Division I. David Boda and David Alejandro of Fremont Ross both lost in consolation matches, denying them a shot at the state tournament.

Boda, 112, lost a 6-1 decision to Dan Smith of Lexington in the semifinals and then was stopped by Troy Cameron of Hilliard 11-10 in the consolation quarterfinals. The Ross senior led 10-6 with a minute left but was caught for five-point move while shooting for a takedown. Boda was on his back the last 45 seconds of the match.

Alejandro lost 7-4 to Jeff Altman of Holland Springfield in the first round of consolations.
