

FOURTEEN SCHOOLS ENTERED

151 Grapplers In Fremont Sectional

Heavy schedule of wrestling competition is slated for this weekend at Fremont junior high school. As the result of drawings made last night in the Ross high school cafeteria there will be 151 high school wrestlers from 14 schools competing in 195 bouts this weekend.

The action in the girls gymnasium of the junior high school will all be part of the Sectional wrestling tournament. When dust settles on the mats Saturday night 33 boys from this sectional will have qualified for the District tournament to be held in Toledo.

The Fremont Sectional is one of five in this district which serve as the first steps to the state high school wrestling championship tournament.

James Michaels and Mal Mackey of Ross and Joe Kuzma of St. Joseph represented local schools at the drawings. Richard Sherman, athletic manager of Ross and tournament manager, directed the drawings.

Teams competing in the sectional will be Arcadia, Bellevue, Margaretta, Clyde, York, Fostoria, St. Joseph, Ross, Lakota, Port Clinton, Sandusky, Perkins, Sandusky St. Mary's and Vermilion.

Four boys were seeded in

each of the 11 weight divisions. The coaches then drew for positions with two byes in all divisions and a third bye resulting from fewer entries in the 106, 123 and 178-pound classes. Neither Ross nor St. Joseph had a top-seeded boy in the tournament.

Ross had two seeded wrestlers, Jim Waggoner, 141, and George Branco, 157. Both these boys received second seeding in their weight class.

St. Joseph had one boy seeded second, Denny Tischler, 168; three seeded third, Jim Szymanowski, 148; Tom LeSavage,

157, and Rob Gibson, 178; and two placed fourth in the seedings, Bill Fredericks, 141, and Gary Gloer, 136.

Seedings were made on the basis of won-lost records with a minimum of seven matches needed for seeding.

The tournament will be conducted in two brackets with the winner of each bracket in each weight advancing to District. The third district entrant will be decided in a consolation bracket. All preliminary round losers are eliminated. After this round the losers drop into the consolation bracket for a second chance. The winner in this consolation round then becomes the third District entrant.

Seedings indicate Arcadia would have the greatest number of men to beat. The Arcadia team has three men seeded top in his division, two seeded second and two seeded fourth for a total of seven seeded wrestlers.

Lakota was the only other team to have more than one top-seeded entrant with Earl Sleek, 148, and Jim Kiser, 157. Clyde had one top-seeded man in Paul Imke, 130.

Other top seeded wrestlers were Dennis Purcell, Port Clinton, 130; Marvin Wright, York, 168; Steve Smith, Fostoria, 123; Mike Lalond, St. Mary's, heavyweight, and Bob Scally, 178, Sandusky.

There will be no team champion determined in this competition, only three individual entrants in District.

Sectional Mat Tourney Set For Four Sessions

The preliminary bouts in each of 11 weight classes in the Fremont wrestling tourney at 3:30 p.m. A second session at 6 p.m. will see the wrestlers in the quarter-final round of the tournament.

Two of the three champions to advance to district tournament will be determined Saturday with matches opening at 2:30 p.m. Competition will be in the quarter-finals and finals of the two winners' brackets and preliminaries of the consolation bracket. The final district representative will be determined Saturday, starting at 7 p.m., when consolation semifinals and finals will be held.



Three More Fremont Matters In District

Three more Fremont boys qualified for the district wrestling tournament Monday afternoon by capturing two consolation matches. The three named Monday join six who went through their brackets un-

beaten Saturday to win district berths.

Latest local additions to the list of sectional winners are Gary LaMaitre, 115, Ross; Jim Lenhart, 123, and Tom LeSavage, 157, both of St. Joseph.

Port Clinton was the big winner in the consolation round with three of its wrestlers capitalizing on the last chance offer for tickets to the district. After Saturday night only Tom Jones, 120, represented Port Clinton on the district entry. Monday Jones was joined by teammates Larry Kokinda, 141; Tracy Bunning, 178, and Jim Rofkar, heavyweight.

Other consolation round winners were Jim Smith, 103, Clyde; Ron Markoff, 130, Fostoria; Ron Beach, 136, Arcadia; Kurt Kuhnle, 148, Vermilion; Tony Myers, 168, Sandusky.

The district entries from Fremont sectional testify to the balance of talent throughout the section. Sandusky and St. Joseph each placed five boys among sectional winners. Ross and Arcadia had four, Bellevue, Port Clinton, Clyde and Fostoria qualified three boys, Lakota two and Vermilion one.

Accuracy of the pre-tournament seedings was indicated in the list of winners. The top-seeded man failed to qualify in only four weight classes, 130, 157, 168 and heavyweight. In every case where the top-seeded man didn't qualify the number two man made the grade. In six weight divisions the top two seeded men won district tickets and in four weights all three of the survivors were seeded men. Four were seeded in each weight.

Next step for the Sectional survivors is the district tournament Friday at Toledo Rogers. Here they will compete with sectional winners from Mansfield, Napoleon, Toledo Rogers and Toledo Bowsher. Each of these sectionals qualified three wrestlers in each of the 11 weight classes.

Four boys in every weight division will go from the Rogers

district to the state tournament in Columbus. The district tournament will be wrestled Friday starting at 5 p.m. Two victories will qualify a boy for the state tournament. The entire district tournament will be wrestled off Friday night.

Russell, Hudson Unanimous Picks

CHICAGO (AP) — The 1965 All-Big Ten basketball team named by the Associated Press Monday has exceptional scoring and rebounding, with Cazzie Russell of Michigan and Lou Hudson of Minnesota unanimous choices.

Dave Schellhase of Purdue was only one point short of unanimity in a poll of AP sports writers in the Big Ten area. The team is rounded out by 6-8½ Skip Thoren of Illinois and 6-7 Bill Buntin of Michigan, the only seniors. The rest are juniors.

Russell, Schellhase and Buntin are holdovers from the 1964 team.

All five players are averaging more than 20 points in conference action, headed by Schellhase with 27.7 in his first 11 games, Russell 26.5 and Hudson 24.4.

Heading the second team, and missing the first by only one point, were Illinois' Tal Brody and Indiana's Tom Van Arsdale. They were joined by Dick Van Arsdale of Indiana, Chris Pervall of Iowa and Stan Washington of Michigan State.
