Opelt still competing in delayed pole vault

Woodmore fourth in district, Lytle just misses state trip

PERRYSBURG—Woodmore's Wildcats, sectional champions in Class AA, made the strongest showing by area teams in district competition Saturday.

The Wildcats finished tied for fourth in the Class AA district at the Lucas County Recreation Center.

Oak Harbor and Genoa were not far behind the Wildcats in the Class AA competition.

In the Class AAA competition, Ross finished well down the list, still had a chance to move up the ladder and qualify one man for the state.

The pole vault was halted in mid stream—and that's just about what it was because of the rains.

Jeff Opelt was among the competitors still in the running for the championship. Opelt took two jumps at 12' and missed

in the slippery weather. The decision was then made to finish the event today. Opelt could have tried his third jump at 12', but decided instead to pass that height and wait for possible good weather today. Because he passed and because he missed twice, Opelt will have just one chance to clear 12'.

Ross has already scored seven points in the district, which were enough to qualify him over Sandusky.

Rob Lytle just missed qualifying for the state Class AAA meet. Lytle finished third in the 100-yard dash and in the Class AAA competition, only the first two finishers qualify.

Lytle was in second place with about 15 yards to go, but Terry Carter of Mansfield Malabar edged him out at the end.

Lytle, who ran a 10.0 to win his preliminary heat, ran a 10.2 in the finals. Al Mayfield of Sandusky was the winner with a

time of 10 seconds flat. Carter was clocked in 10.1.

The 880-yard relay team of Randy Robertson, Doug Hopper, Jon Smith and Scott Barman earned another point for the Little Giants.

With Robertson running a strong anchor leg, the quartet finished sixth in the field.

Mike Harman of Lakota was the winner in the 100.

Sandusky, however, advanced a strong crew to the state competition. The Blue Streaks have Mayfield in the 100 and 220, Jim Fantozzi in the high and low hurdles, Stan Johnson in the shot put and Osmund Pearson in the mile. All advance as district champions except Pearson who finished second in the mile run.

In the Class AA competition at the same site, Woodmore

had 24 points to tie Bryan for fourth place. Willard won the district with 38 points. Perrysburg had 34 and Ontario had 28 1/2.

Jon Giesler, who finished second in the discus and third in the shot put, and John Harman, who was third in the long jump, led the Wildcats to their fourth place finish.

Oak Harbor had 17 points, Genoa 16 and Lakota 15.

Genoa had 17, Lakota scored 10 and one-third points. Clyde and Goshen each earned 8 points with the Golden Bears getting all of theirs by virtue of Jon Sage's second place finish in the high hurdles.

Tom Hammer of Lakota turned in the best individual performance of the day, hurling the discus 183' to set a new district record.

Jim Flower second in district tennis

Jim Flower, Ross High sophomore, will move on to the Class AAA state tennis tournament as the runnerup in the Toledo District.

Flower was top seeded and who qualified for the state play by winning two matches in the district, lost in the finals to Eric Iskerky. St. John's freshman who was ranked in the top 14 in the under 14 age group last year.

Iskerky defeated Flower in the finals at the University of Toledo, 6-2, 6-3.

Ross coach Pete Michaels called the match a hard fought battle. He praised Iskerky for playing "flawlessly" in the match.
