Smith wins sectional shot put crown

SANDUSKY — Laurie Smith won the Class AAA Girls Sectional discus title Thursday during the first of two days of action in track and field.

Smith sailed the discus, the only final event of the day, 108 feet, 11 inches to take the title and advance to next week's district meet.

Preliminaries to set up Saturday's finals were the main order of the day at Strobel Field. Several Ross girls and boys advanced out of the Thursday events to the finals.

Tammy Haas posted the day's quickest time in the girls 100-meter hurdles, 15.3, and polished that time off with the fastest time of the day in the 800 with a 2:26 for the Little Giants. Della Hall qualified in the 100 and 200 meter dashes. Beth Randolph was a 200 qualifier.

The 3200 meter relay team of Celenea Simmons, Lisa Arndt, Sandy Long and Joan Osmon also made it into Saturday's field. Simmons and Arndt reached the finals in the 1600 meter run.

In the boys division, Tom Pendrey qualified in the high and low hurdles for Saturday's semifinals. Curtis Lee and Sam Lindsey in the 100 along with Mark Balsizer and Rick Heidelberg in the 200 also qualified for the semifinals in those sprints Saturday.

Eric Bates will be in the low hurdles semis for the Little Giants.

Oliver Zimmerman

reached the finals in the 1600 meters with Todd Johnson making it in the 400.

Ross's two relay teams, the 400 and 1600, made it to the finals. The 400 team

consists of Lee, Tony Gant, Balsizer and Pendrey. The 1600 is made up of Bates, Gant, Johnson and Jock Hicks.

In the field events, Gant and Ron Thrun reached the

long jump finals. Thrun also made it in the high jump while Jeff Ruggiero qualified in the discus for Ross.

Ross girls finish second, boys fifth in sectionals

Ross's girls finished second and the boys fifth in the Class AAA sectional track meets.

Tammy Haas and Laurie Smith won two events apiece but the Lady Little Giants lost by a point, 50 to

49, to Mansfield Senior.

Haas set a sectional record and a new Ross school record in the hurdles and a 800 meter run. She won the hurdles in 15.6 seconds for the sectional mark and posted a 2:23.4 for a new sectional and a school record in the 800 meters.

Smith won the shot put and the discus. She had distances of 36-9 1/4 in the shot and sailed the platter 108-11.

The Ross 3200 meter relay team of Joan Osmom, Celena Simmons, Lisa Arndt and Sandy Long was fourth in 10:32.5 while qualifying for the district

this weekend.

In the boys meet, Ross was fifth out of 12 teams but junior Tony Gant wiped out a Ross long jump record that has stood since 1956.

Gant cleared 22 feet, 8 1/2 inches to gingerly break the record that Jim Tiller had held for 25 years. Tiller's old mark was 22-8.

Tom Pendrey qualified for two events, finishing fourth in the high hurdles in 15.2 seconds and taking second in the 300-meter low hurdles in 38.9 seconds.

Curtiss Lee ran an 11.4 to finish fourth in the 100 meters. Todd Johnson was fourth in the 400 meters

with a season best of 50.6 seconds.

The Little Giants' 400 meter relay team was second in 43.4. Lee, Gant, Mark Balsizer and Pendrey comprised the team.

The Ross 1600 relay squad of Eric Bates, Gant, Johnson and Jock Hicks finished third in 3:27.9.

Oliver Zimmerman is an alternate in the mile, taking fifth in 4:31.4, the quickest time this season for a Ross runner.

In other sectionals, Gibsonburg will send six to the Class A boys at Lucas County Recreational Center.
